## TRANSFERABLE LIMITED WARRANTY

Republic Windows & Doors, Inc., warrants that its premium vinyl windows and doors will be free from material and manufacturing defects, under normal use and service, for as long as you own and reside in your home, where such windows and doors are installed, except as otherwise noted below.

If the windows and doors covered by this Warranty are defective, Republic will repair or replace the defective part(s). Republic will provide the repair or replacement part(s) to you free of charge, except as otherwise provided for herein. You must pay for the labor costs of removal, installation or reinstallation of the part or component, or the entire window or door, if necessary, in order to effect the repair.

### **BASIC WINDOW/DOOR UNIT—LIFETIME**

The rigid vinyl extrusions utilized in manufacturing the main window/door frame, and sash/panel frames are warranted against cracking, blistering, peeling, corroding or flaking and will not warp or rot under normal use and service for the duration of this Warranty. Normal weathering is not included. Two-tone painted finishes are warranted for a period of 10 years.

### **SCREEN AND SCREEN FRAME—LIFETIME**

The screen cloth and screen frames are warranted against rolling, rusting, or corroding, except for normal weathering, for the duration of this Warranty. Screening torn during installation or during use is not warranted.

### **MISCELLANEOUS PARTS OR COMPONENTS—LIFETIME**

Moving parts such as rollers, balances, locks or ventilation latches; weatherstripping and other Republic manufactured component parts are warranted against defects in materials and manufacturing for the duration of this Warranty.

### **INSULATING GLASS—LIFETIME**

Insulating glass units of the windows/doors are warranted against the development of material obstructions, dirt, films, or moisture collections between the interior surfaces of the insul glass unit caused by the failure of the glass seal from the date of installation for the duration of this Warranty.

If the glass seal should fail prior to the twenty fifth anniversary of the installation date, a new glass unit would be supplied at no cost, excluding labor to install the new unit. Should the glass seal fail after year 25 resulting in any defect described above, you must pay a pro-rated cost of the retail replacement price of the new insul glass unit, based on the following: Year 25 through 30 - 50%, Year 30 through 35 - 70%, Year 35 through 40 - 80%, Year 41 and beyond - 90%

### **INSTALLATION, INSTALLATION ACCESSORIES, WOOD**

Installation accessories, installation labor, caulking, or insulation utilized in the installation of window/door products; wood framing, wood trim, and other accessories not manufactured by Republic are not warranted by Republic. The wood head, jambs, and/or seal boards used in construction of bow, bay, or garden windows supplied by Republic must be treated, sealed, stained or painted within 30 days to prevent absorption of moisture and/or staining or discoloration due to not being protected by commercially acceptable bare wood preparation, painting and staining techniques. In addition, Republic recommends that each: bow, bay, and garden window unit, regardless of size, be knee braced and insulated properly. Republic will not warrant: (a) any product that fails due to improper or unauthorized installation, or (b) oversized products manufactured beyond Republic's recommended size ranges.

This Warranty only covers defects in manufacturing or materials specified herein. Defects due to weather, accidents, flood, fire, or other Acts of God; riots, vandalism, pollutants, building settlements, or structural failure of foundations, roofs, or walls, or excessive stress of temperatures over the window surfaces; or any event or condition not within the control of Republic are not covered.

This Warranty does not cover condensation nor frost or fogging of the glass or frames on the interior surface of the windows/doors which is caused by excessive humidity inside the house or building.

### CLAIMS PROCEDURE

To obtain warranty service, you should notify Republic, and the distributor, dealer, or other business which sold the window(s)/door(s) to you, in writing, of the nature of your problem. In your written notice, please provide the date of purchase and the sticker information from the window(s)/door(s) in question. In some cases you may be required to ship the defective part, component, or window(s)/door(s) back to the dealer, distributor, or factory for repair, transportation or freight charges prepaid. In the event of such repair or replacement, the remaining warranty period of the original warranty shall apply to the replacement part. If no warranty period remains, the new part shall be warranted for 12 months. If Republic no longer manufactures the identical part or component, Republic reserves at its option, the right to substitute a part or component of equal value as a replacement.

REPUBLIC MAKES NO OTHER WARRANTY OR REPRESENTATION OF ANY KIND WHATSOEVER EXPRESSED OR IMPLIED, AND ALL IMPLIED WARRANTIES INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE HEREBY DISCLAIMED.

The parties hereto irrevocably waive any right to trial by jury in any action or proceeding to enforce or defend any rights under or in connection with this warranty or arising from any dispute or controversy in connection or related to this warranty and we agree that any such action or proceeding shall be tried before a court and not before a jury.

Any action brought to enforce the terms of this warranty shall be in a court having its situs in the city of Chicago, county of Cook, state of Illinois.

Republic's maximum liability hereunder is limited to the current wholesale price of the defective window(s)/door(s). In no event shall Republic be liable for any consequential, indirect, incidental or special damages of any nature arising from the sale or use of such window in contract, tort, strict liability or otherwise. No change, written or verbal, in this Warranty is authorized by Republic.

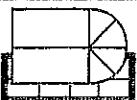

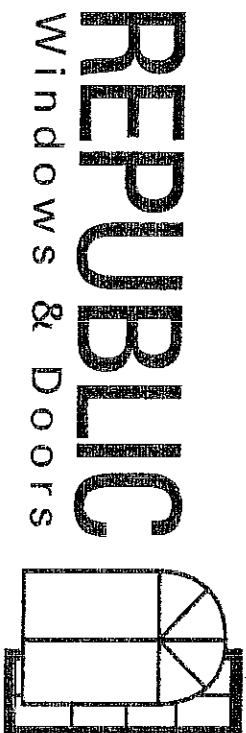
